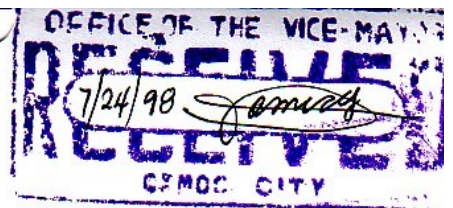
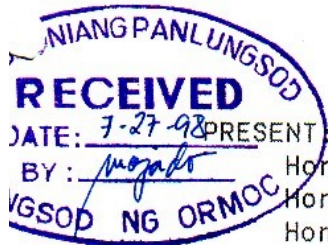



ADOPTED, July 23, 1998.


