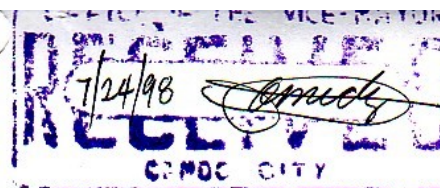

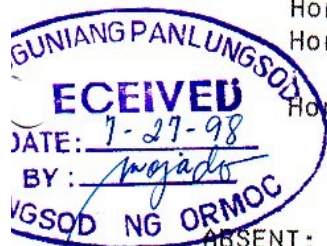

RESOLUTION NO. 98-20

A RESOLUTION CONCURRING THE APPOINTMENT OF CRISTETA B.  
TUGONON AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY  
ASSESSOR) EFFECTIVE JULY 1, 1998.

PRESENTED for concurrence by this august Body, through 1st  
Indorsement dated 17 July 1998 from the Honorable City Mayor, is the  
Appointment of Mrs. Cristeta B. Tugonon as City Government Department  
Head I (City Assessor), this city;

WHEREAS, Art. 119, Par. (a). Rules and Regulations Implementing the  
Local Government Code of 1991 provides:

"(a) Unless otherwise provided in this Rule, heads of  
offices and departments in the LGU's shall be appointed  
by the Local Chief Executive concerned with the  
concurrence of a majority of all the members of the  
sanggunian, subject to civil service laws, rules and  
regulations."

WHEREAS, this august Body, through the representation of the  
Honorable Chairman, Committee on Good Government & Ethics, finds out  
that the appointment of Mrs. Cristeta B. Tugonon to the said position is  
in accordance with pertinent provisions of the Local Government Code;

NOW, THEREFORE, on motion of Kagawad Jose S. Serafica, Chairman,  
Committee on Good Government, Ethics and Human Rights, jointly seconded  
by Kagawad Nepomuceno P. Aparis I and Chiqui B. Labagala; be it

RESOLVED, to pass a resolution CONCURRING THE APPOINTMENT OF  
CRISTETA B. TUGONON AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY ASSESSOR)  
EFFECTIVE JULY 1, 1998;

ADOPTED, July 23, 1998.
