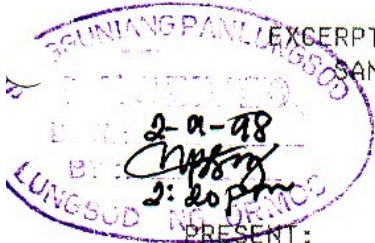
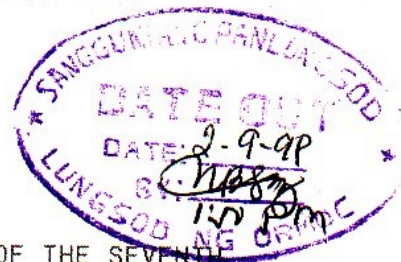

RESOLUTION NO. 98-21

A RESOLUTION TO RETURN TO THE SANGGUNIANG PAMBARANGAY OF GREEN VALLEY THEIR ORDINANCE NO. 98-03, ENTITLED: "AN ORDINANCE REGULATING THE USE OF OUR WATER RESOURCE FROM THE BARANGAY WATER SYSTEM, AND PRESCRIBING THE RATES THEREIN, AND PROVIDING PENALTIES IN VIOLATION HEREOF" FOR THE REASON THAT THE CERTIFICATION REGARDING THE CONDUCT OF PUBLIC HEARING, THE DATE THEREOF IS LEFT BLANK.

WHEREAS, this august Body is in receipt of Ordinance No. 98-03, entitled: "AN ORDINANCE REGULATING THE USE OF OUR WATER RESOURCE FROM THE BARANGAY WATER SYSTEM, AND PRESCRIBING THE RATES THEREIN, AND PROVIDING PENALTIES IN VIOLATION HEREOF" submitted by the Sangguniang Pambarangay of Green Valley for review as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, the aforementioned Ordinance disclosed that the date when the required public hearing was conducted is left blank;

WHEREAS, Section 187 of the Local Government Code of 1991, in part provides:

"X X X Provided, further, That the ordinance levying such taxes, fees or charges shall not be enacted without any prior public hearing conducted for the purpose."
(Underscoring supplied for emphasis)

WHEREAS, the aforequoted provision emphasizes the importance and the need of a prior public hearing prior to the enactment of the Ordinance under review, hence, the omission of the date when the public hearing was conducted cannot be ignored or condoned;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Claudio P. Larrazabal and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution TO RETURN TO THE SANGGUNANG PAMBARANGAY OF GREEN VALLEY THEIR ORDINANCE NO. 98-03, ENTITLED: "AN ORDINANCE REGULATING THE USE OF OUR WATER RESOURCE FROM THE BARANGAY WATER SYSTEM, AND PRESCRIBING THE RATES THEREIN, AND PROVIDING PENALTIES IN VIOLATION HEREOF" for the reason that the certification regarding the conduct of public hearing, the date thereof is left blank;

ADOPTED: 06 February 1998.
