

MENDOLA, LOCATED AT BARANGAY TAMBULILIO, ORMOS CITY, COMPRISING LOT 1-A, PSD-083738-007113-D AND LOT NO. 5248-B-8-A, PSD-08-009246-D, HAVING A TOTAL PROJECT AREA OF 19,731 SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 30274 CONTAINING ONE HUNDRED EIGHTY THREE (183) SUBDIVISION LOTS EXCLUDING COMMUNITY FACILITIES, PARK AND PLAZA AND ROAD LOTS.

An Application for Development Permit of RUVI VILLAGE III SUBDIVISION with Preliminary Approval and Locational Clearance No. PALC-022-98 as per SP Resolution No. 98-89 s. 1998 particularly lot 1-A Psd-083738-007113-D and Lot No. 5248-B-8-A, Psd-08-009246-D, owned by Dolores E. Mendola and Ruvinieu E. Mendola located at Barangay Tambulilid, Ormoc City, having a total project area of 19,731 square meters by Transfer Certificate of Title 30274 containing one hundred eighty three (183) subdivision excluding community facilities, park and plaza and lots.
