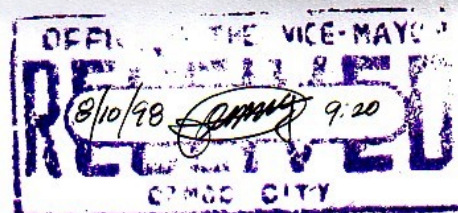
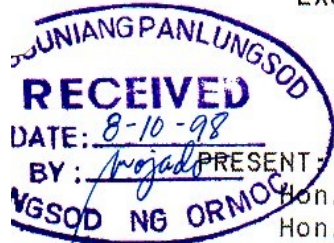

A RESOLUTION EXPRESSING HEARTFELT CONGRATULATIONS TO THE

PRESTIGE TO THE CITY OF ORMOC BY WINNING AWARDS IN THE  
RECENTLY CONCLUDED 22ND MILO MARATHON REGIONAL  
ELIMINATION ON AUGUST 02, 1998 HELD IN TACLOBAN CITY IN  
THEIR RESPECTIVE CATEGORIES.

WHEREAS, the AMA DDB Phils. Inc., promotion arm of MILO, sponsored  
a Marathon Regional Elimination on August 02, 1998 held in Tacloban  
City. This aims to boost marathon running as an expensive form of  
physical fitness as a means of promoting sports development in the  
grassroots level.
