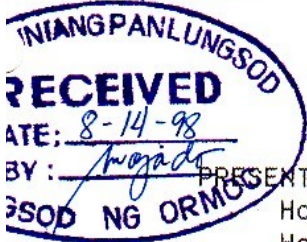
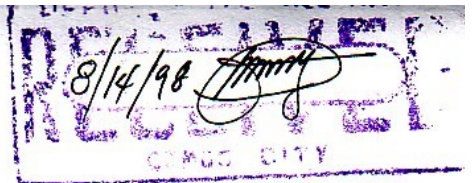

RESOLUTION NO. 98-31

A RESOLUTION DECLARING AQUINO VILLAGE, BARANGAY COGON AND SITIO LARAY, BARANGAY DON CARLOS RIVILLA, BOTH OF THIS CITY, AS CALAMITY AREAS, BROUGHT ABOUT BY THE FIRE THAT GUTTED SEVERAL HOUSES IN THE SAID AREAS LAST MARCH 1, 1998 AND JUNE 3, 1998, RESPECTIVELY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 3 August 1998 from the Office of the City Mayor of Resolution No. 01 s. 1998 entitled, "A RESOLUTION DECLARING AQUINO VILLAGE, BRGY. COGON, THIS CITY, CALAMITY AREA WHEREIN 45 FAMILIES WERE DECLARED HOMELESS AS A RESULT OF THAT UNFORTUNATE FIRE WHICH OCCURED LAST MARCH 1, 1998. REQUESTING FURTHER THE HONORABLE MEMBERS OF THE 8TH SANGGUNIANG PANLUNGSOD FOR A RESOLUTION DECLARING THE AFOREMENTIONED AREA AS CALAMITY AREA" and Resolution No. 03 s. 1998 entitled, "A RESOLUTION RECOMMENDING TO THE HONORABLE MEMBERS OF THE 8TH SANGGUNIANG PANLUNGSOD TO DECLARE SITIO LARAY, DON CARLOS RIVILLA, AS CALAMITY AREA WHEREIN 13 FAMILIES WERE GREATLY AFFECTED BY THE FIRE WHICH OCCURED JUNE 3, 1998 AT EXACTLY 12:30 IN THE AFTERNOON" both of the City Disaster Coordinating Council, this city;

WHEREAS, Section 1 of Republic Act No. 8185 entitled, "AN ACT AMENDING SECTION 324 (d) OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991" provides:

"SECTION 1. Section 324 (d) Republic Act No. 7160 is hereby amended to read as follows:

(d) Five per cent (5%) of the estimated revenue from regular sources shall be set aside as annual lump sum

appropriations for relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year: Provided, however, that such fund shall be used only in the area, or a portion thereof, of the Local Government Unit or other areas affected by a disaster or calamity, as determined by the local sanggunian concerned";

WHEREAS, this august Body has considered said request valid and reasonable, hence, be accorded with due course of action;

NOW, THEREFORE, on motion of Kagawad Dennis Y. Capuyan, Chairman, Committee on Health and Social Welfare severally seconded by Kagawad Benjamin B. Lladoc, Sotero M. Pepito and Chiqui B. Labagala; be it



ADOPTED, August 12, 1998.


