A RESOLUTION APPROVING RESOLUTION NO. 5 SERIES OF 1998 OF THE CITY DISASTER COORDINATING COUNCIL (CDCC), ORMOC CITY, ENTITLED: A RESOLUTION APPROVING THE RELEASE OF FOUR HUNDRED SEVENTY TWO THOUSAND ONE HUNDRED SIXTY PESOS (P472,160.00) CALAMITY FUND FOR PALAY SEEDS PROCUREMENT FOR DISTRIBUTION TO THE EL NINO AFFECTED FARMERS OF ORMOC CITY".

WHEREAS, this Sanggunian is in receipt of Resolution No. 05 s. 1998 the City Disaster Coordinating Council, this city entitled, "A RESOLUTION APPROVING THE RELEASE OF \$472,160.00 CALAMITY FUND FOR PALAY SEEDS PROCUREMENT FOR DISTRIBUTION TO THE EL NINO AFFECTED FARMERS OF ORMOC CITY";
