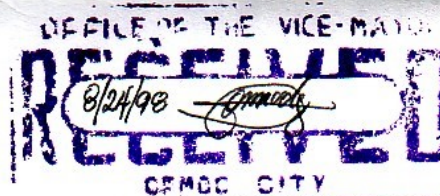
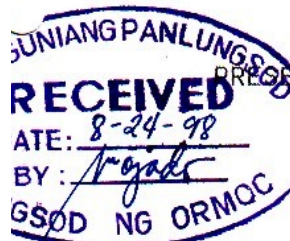

and Sotero M. Pepito; be it


RESOLVED, to pass a resolution APPROVING SUPPLEMENTAL BUDGET NO. 03

ADOPTED, August 20, 1998.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
