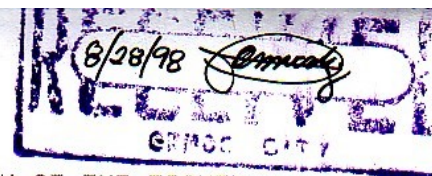
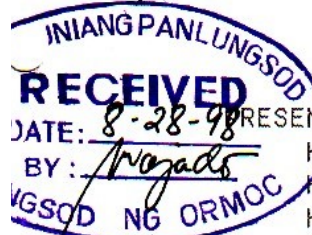

ADOPTED, August 27, 1998.


