RESOLUTION NO. 98-41

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO ENTER INTO A NEGOTIATED
CONTRACT WITH MAC BUILDERS FOR THE CONSTRUCTION OF
ORMOC CITY PUBLIC MARKET "BUILDING C" PHASE II, IN THE
AMOUNT OF TEN MILLION PESOS ONLY (P10,000,000.00).

WHEREAS, this Sanggunian is in receipt of a letter dated 18 August 1998 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for authority to enter into a negotiated contract with MAC Builders for the construction of Ormoc City Public Market "Building C" Phase II per Pre-qualification Bids and Awards Committee (PBAC) Resolution No. 98-08-59 dated 7 August 1998 in the amount of TEN MILLION PESOS ONLY (P10,000,000.00);

WHEREAS, the Pre-qualification Bids and Awards Committee (PBAC) Resolution no. 98-08-59 dated 7 August 1998 mentioned, among others, the following:

- a) That it will result in less mobilization cost considering that the heavy equipment of same contractor are readily available at site and that "Building C" (Phase II) is contiguous to an on-going project Phase I and it could be economically presented by the same contractor;
- b) That implementation of Phase I of said contractor has no negative slippage and has demonstrated satisfactorily, having accomplished ahead of schedule with excellent performance and;

- c) That the Office of the City Engineer is not in the position of undertaking said project due to limited heavy equipment per Certification of the City Engineer dated 5 August 1998.

WHEREAS, this august Body has considered said request valid and reasonable, hence, must be given due course of action;

NOW, THEREFORE, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by Kagawad Benjamin B. Lladoc and Fernando P. Parrilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO A NEGOTIATED CONTRACT WITH MAC BUILDERS FOR THE CONSTRUCTION OF ORMOC CITY PUBLIC MARKET "BUILDING C" PHASE II, IN THE AMOUNT OF TEN MILLION PESOS ONLY (P10,000,000.00).;
