Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it


RESOLVED, to pass a resolution APPROVING SUPPLEMENTAL BUDGETS NO.

ADOPTED: September 3, 1998.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
