

CONCRETING HI-WAY TO JICA RESETTLEMENT, ORMOC CITY - - . P1,500,000.00

. REHABILITATION OF ROADS. SAN PABLO, ORMOC CITY 93,750.00

WHEREAS, this Sanggunian is in receipt of a letter dated 28 August 1998 from the Officer-In-Charge, Leyte Fourth Engineering District, informing and requesting approval of the corresponding Programs of Works and Detailed Estimates, namely:
