A RESOLUTION REQUESTING SUPERINTENDENT ELMER B. ASUMBRADO, CHIEF ADMINISTRATIVE OFFICER, BUREAU OF FIRE PROTECTION (BFP) REGIONAL OFFICE NO. VIII, TACLOBAN CITY TO FURNISH THE SANGGUNIANG PANLUNGSOD NG ORMOC THE LIST OF ACTUAL AMOUNT ALLOCATED AND SENT TO ORMOC BFP FOR THE LAST THREE (3) YEARS.

WHEREAS, this Sanggunian has received information that the Bureau of Fire Protection (BFP) Ormoc City Station is allotted Forty Thousand Pesos (P40,000.00) per quarter for Repair of Vehicles as well as allotment is also given for gasoline/lubricants tires and other releases for the good of public service;

WHEREAS, at present, this august Body is officially informed from a reliable source that three (3) firetrucks are not anymore serviceable for quite a time inspite of the allotment for repair of vehicles given to Ormoc BFP;
