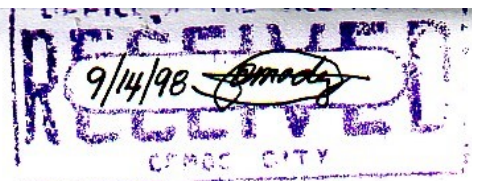
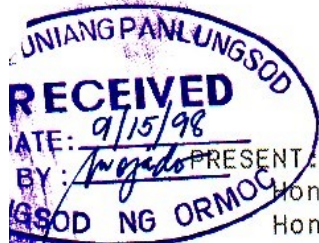

WHEREAS, this Sanggunian is in receipt of a letter dated 26 August 1998 from the Honorable City Mayor requesting that a new resolution be passed amending Resolution No. 30 creating the Personnel Selection and Promotion Board and recommending the Honorable Vice Mayor to take the place of Vice Chairman of said board vacated by Atty. Benjamin F. Tugonon;

WHEREAS, Sec. 80 Par (b) of the Local Government Code of 1991 provides that "there shall be established in every X X X city X X X a personnel selection board to assist the Local Chief Executive in the judicious and objective selection of personnel for employment as well for promotion, X X X X";

WHEREAS, Sec. 80 Par (c) of the same code has also provides that "the personnel selection board shall be headed by the local chief executive, and its members shall be determined by resolution of the Sanggunian concerned X X X X" (Underscoring Supplies);
