

RESOLUTION NO. 98-54

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF QUEZON JR., THIS CITY, THEIR RESOLUTION NO. 11 SERIES OF 1998, ENTITLED: "A RESOLUTION PROVIDING MAINTENANCE AND PENALTY OF WATER SUPPLY OF BARANGAY QUEZON JR.", WITH THE REQUEST THAT THE SAME BE REVISED TO CONFORM WITH THE OBSERVATIONS STATED HEREIN.

WHEREAS, this Sanggunian is in receipt of Resolution No. 11 series of 1998 of Barangay Quezon, Jr., entitled, "A RESOLUTION PROVIDING MAINTENANCE AND PENALTY OF WATER SUPPLY OF BARANGAY QUEZON JR.", which is submitted for review as mandated by the Local Government Code of 1991;

WHEREAS, a review of the aforesited Resolution disclosed the following to wit:

- Said resolution be revised to exclude the imposition of penalty for the destruction of water pipes since this is already funishable under the Revised Penal Code, and;
- 2) It is recommended that a new ordinance be passed to impose the payment of \$5.00 monthly water bill for residential houses.
