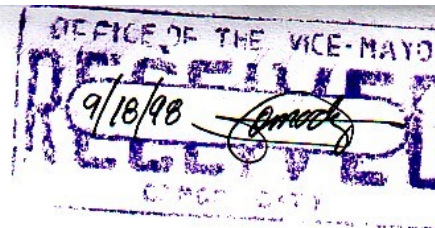
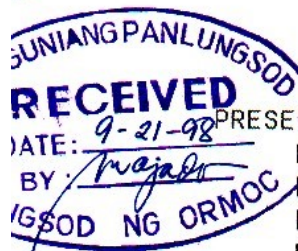

NOW, THEREFORE, on MASS MOTION of the Body and MASS SECONDED; be it



ADOPTED, September 17, 1998.


