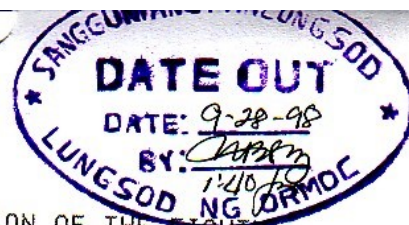

RESOLUTION NO. 98-56

A RESOLUTION GRANTING SOCIAL ACCEPTABILITY TO THE
OPERATION OF POULTRY AT SITIO TALONG, BARANGAY LILO-AN,
ORMOC CITY, OWNED AND OPERATED BY DR. ALBERTO TAVEROS
BASED ON THE PUBLIC HEARING AND RESOLUTION OF REQUEST
FOR SOCIAL ACCEPTABILITY BY THE BARANGAY COUNCIL OF
LILO-AN.

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No.
98-21 of Barangay Lilo-an, this city, entitled, "A RESOLUTION REQUESTING
APPROVAL FROM THE HONORABLE CITY MAYOR, EUFROCINO M. CODILLA, SR., TO


