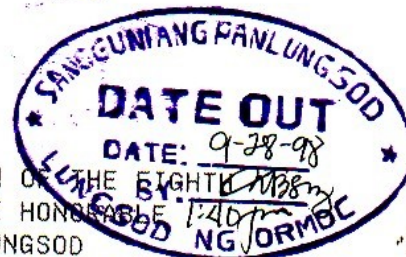
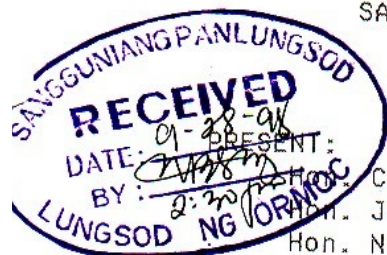

Local Finance Committee;


NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman,

BUDGET NO. 01 OF BARANGAY DISTRICT 16, THIS CITY;


