A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST CURRENT APPROPRIATION FOR COMMUNICATION
SERVICES THE UNPAID ORTELCO ACCOUNTS OF ORMOC CITY
SUPERDOME COVERING THE PERIOD - 1997 IN THE AMOUNT OF
P14,321.00.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 18
June 1998 from the Honorable City Mayor, Eufrocino M. Codilla, Sr., of
the request of the Officer-In-Charge, City Treasurer's Office for
appropriation in the amount of FOURTEEN THOUSAND THREE HUNDRED TWENTY
ONE PESOS (P14,321.00) for payment of telephone installation and monthly
rentals covering the period April 1997 to December 1997 of the Ormoc
City Superdome;

WHEREAS, the City Budget Officer through 4th Indorsement dated 24
June 1998 has recommended that said request be held in abeyance until
after the 1998 Annual Budget of the Ormoc City Superdome be approved;

WHEREAS, on August 6, 1998, the Eighth Sangguniang Panlungsod ng
Ormoc enacted Ordinance No. 66 entitled, "AN ORDINANCE APPROVING THE
PROPOSED 1998 BUDGET OF THE ORMOC CITY SUPERDOME IN THE AMOUNT OF ONE
MILLION FIVE HUNDRED FORTY FIVE THOUSAND TWO HUNDRED PESOS
(P1,545,200.00)" wherein part of which in the amount of P20,000.00 is
appropriated for communication services;
