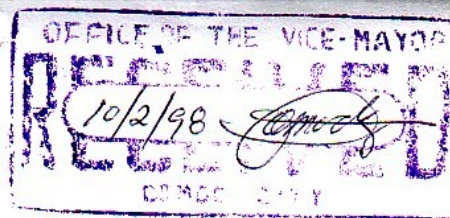

ADOPTED, October 01, 1998.


