

## RESOLUTION NO. 98-62

RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE CURRENT APPROPRIATION THE THREE HUNDRED SIXTY NINE AGAINST AMOUNT THOUSAND PESOS & 50/100 (R1,369.50) FOR PAYMENT OF TELECOMMUNICATION SERVICES OF MUNICIPAL TRIAL COURT IN CITIES FOR THE PERIOD FROM OCTOBER 1997 - DECEMBER 1997.

PRESENTED, to this Sanggunian for consideration is a letter dated September 1998 from the OIC-City Treasurer requesting for an authority to charge against current appropriation the amount of ONE THOUSAND THREE HUNDRED SIXTY NINE PESOS & 50/100 (P1,369.50) for payment of telecommunication services of Municipal Trial Court in Cities for the period from October 1997 - December 1997;

WHEREAS, the City Budget Officer has certified to the existence of appropriation for the expenditure and amount specified as manifested through Request for Obligation of Allotment (Local) dated 24 September 1998;

WHEREAS, the OIC-City Treasurer through the same Request for Obligation of Allotment (Local) has certified as to the availability of funds for said obligation in the amount of P1,369.50;
