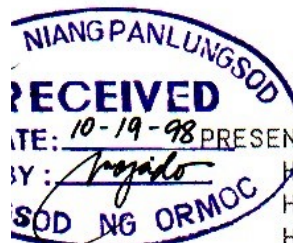


ADOPTED, October 15, 1998.
