


RESOLUTION NO. 98-66

A RESOLUTION TO AMEND RULE X, SECTION 5 OF THE INTERNAL
RULES OF PROCEDURE OF THE EIGHT SANGGUNIANG PANLUNGSOD
NG ORMOC.

WHEREAS, Section 5 of Rule X of the Internal Rules of Procedure of
this Sanggunian, provides:

"Copies released with authority. Copies of records on
file shall not be released without express authority of the
Sangguniang Panlungsod."

WHEREAS, aforequoted provision of the Internal Rules of Procedure
is contrary to the policy of transparency enunciated and adopted by the
National Government, to which this Sanggunian subscribes to; and
moreover, Section 469, par. (c) (5) of the Local Government Code of
1991, relative to the duties of the Secretary to the Sanggunian
provides:

"Furnish, upon request of any interested party,
certified copies of records of public character in his
custody, upon payment to the treasurer of such fees as may
be prescribed by ordinance."

WHEREAS, to conform to the foregoing policy, and provision of law,
there is a need to amend Section 5 of Rule X of the Internal Rules of
Procedure of this Sanggunian;

FOREGOING PREMISES CONSIDERED, on motion of Kagawad Mariano Y.
Corro, Chairman, Committee on Internal Rules, severally seconded by mga
Kagawad Claudio P. Larrazabal, Chiqui B. Labagala, Benjamin B. Lladoc
and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to amend Rule X, Section 5 of the Internal Rules of Procedure of the Eight Sangguniang Panlungsod, to now read as follows:

"SECTION 5. Copies released with authority. Copies of records on file, or certified copies thereof, which are confidential in nature as previously classified as such by the Sanggunian, shall not be released except upon express authority of the Sangguniang Panlungsod."

However, the Secretary to the Sanggunian shall furnish, upon request of any interested party, certified copies of records of public character in his custody, upon payment to the City Treasurer of the prescribed fee."

ADOPTED: 15 October, 1998.

RESOLVED, FURTHER, to furnish copies of this Resolution, one each to - The Honorable City Mayor of Ormoc, The Honorable City Vice Mayor and the SP Presiding Officer, and all the Kagawads of this Sanggunian, and other offices concerned.
