RESOLUTION NO. 98-71

A RESOLUTION GRANTING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. WITH AUTHORITY TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF DONATION OF A PARCEL OF LAND KNOWN AS THE PROPOSED SITE OF A NEW BUILDING TO HOUSE RTC BRANCH 35, THIS CITY, CONTAINING AN AREA OF THREE HUNDRED FOURTEEN (314) SQUARE METERS, IN FAVOR OF THE DEPARTMENT OF JUSTICE, PROVIDED THAT OWNERSHIP THEREOF SHALL REVERT TO THE DONOR IN THE EVENT THAT THE DONEE CEASES TO USE THE SAID PROPERTY FOR THE PURPOSE FOR WHICH IT WAS DONATED, AND THEREBY SUPERSEDING RESOLUTION NO. 97-24 OF THIS SANGGUNIAN.

WHEREAS, this Sanggunian is in receipt of a letter dated October 19, 1998, from the Honorable City Mayor of Ormoc, Eufrocino M. Codilla, Sr., informing this august Body that the parcel of land to be donated to the Department of Justice, subject of Resolution No. 97-24 of this Sanggunian, was found to have encroached the property of Iñaki A. Larrazabal, Sr., and recommending that a new site be donated in lieu thereof, thereby superseding aforementioned Resolution No. 97-24; (Attached subject letter of the City Mayor for ready reference.)

WHEREAS, the new site to be donated is adjacent to the parcel of land wherein the Department of Justice Building is located, consisting of Three Hundred Fourteen (314) square meters, as surveyed by Geodetic Engineer Darlito A. Pareja, OIC, Asst. City Assessor of Ormoc; (Attached Technical Description of the land to be donated for ready reference)

WHEREAS, the land to be donated will be used as the site of a new building to house RTC Branch 35, this city;

WHEREAS, this Sanggunian finds the request of the Honorable City Mayor Eufrocino M. Codilla, Sr. valid, appropriate and in order, hence, be afforded with favorable action.

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Sotero M. Pepito, Benjamin B. Lladoc and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution GRANTING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. 
