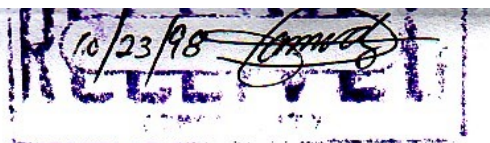
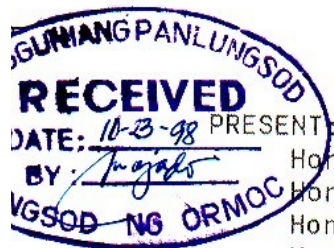

RESOLUTION NO. 98-72

ng Ormoc, having greatly felt the irreparable loss of a conscientious  
and peace loving servant and friend, in SESSION, greatly shares the  
intense pain and sorrow with her husband, Atty. Bruno A. Villamor, Sr.,  
a retired Municipal Trial Court Judge, and children Bruno Jr., Alfeo,  
Jacinto, Juditha, Arlene and Maria Llena as well as the anguish and  
despair with their relatives, for the passing away of a dutiful and  
affectionate mother and an accommodating kin who, for so many years, had  
dedicated her life in public service and could have been more in service  
thereto were she to live longer through the years;
