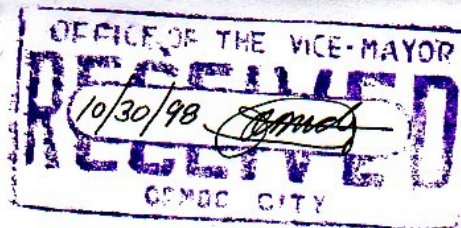

RESOLUTION NO. 98-73

A RESOLUTION DECLARING ORMOC CITY AS CALAMITY AREA HAVING
BEEN AFFECTED BY THE EL NINO PHENOMENON.

WHEREAS, this Sangguniang is in receipt of CDCC Resolution No. 09
series of 1998 entitled, "A RESOLUTION DECLARING ORMOC CITY AS CALAMITY
AREA HAVING BEEN AFFECTED BY THE EL NINO PHENOMENON";

WHEREAS, as stated in said resolution, "Barangay Milagro base water
system is the major source of potable water that could greatly affect
the lives of the people" and that having been greatly affected by the El
Niño Phenomenon, it is imperative that immediate alleviation measures be
undertaken;

WHEREAS, quoted hereunder is Republic Act 8185 entitled, "AN ACT
AMENDING SECTION 324 (d) OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS
THE LOCAL GOVERNMENT CODE OF 1991":

"SECTION 1. Section 324 (d) Republic Act No. 7160 is
hereby amended to read as follows:

"(d) Five percent (5%) of the estimated revenue from
regular sources shall be set aside as annual lump sum
appropriations for relief, rehabilitation, reconstruction
and other works or services in connection with calamities
which may occur during the budget year: Provided, however,

That such fund shall be used only in the area, or a portion thereof, of the Local Government Unit or other areas affected by a disaster or calamity, as determined by the local sanggunian concerned."
