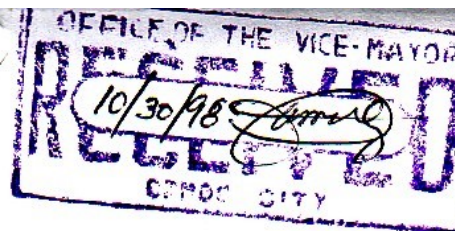
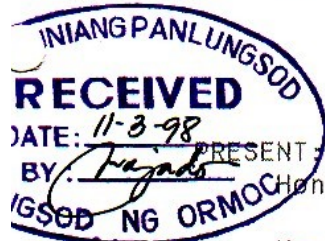

A RESOLUTION APPROVING THE CITY DISASTER COORDINATING
COUNCIL'S (CDC) RESOLUTION NO. 07 SERIES OF 1998
ENTITLED: "A RESOLUTION SETTING ASIDE THE AMOUNT OF 5.5
MILLION PESOS FROM THE 5% CALAMITY FUND FOR THE WATER
SUPPLY SOURCE DEVELOPMENT AND PIPE INSTALLATION FROM
BRGY. MILAGRO TO AUGMENT THE CITY PROPER WATER SUPPLY
AFFECTED BY THE EL NINO; FURTHER REQUESTING THE
HONORABLE MEMBERS OF THE 8TH SANGGUNIANG PANLUNGSOD FOR
THE RELEASE OF THE AMOUNT OF 5.5 MILLION PESOS FOR THE
HEREIN STATED PURPOSE."

WHEREAS, this Sanggunian in receipt of Resolution No. 07 s. 1998 of
the City Disaster Coordinating Council, this city, entitled, "A
Resolution setting aside the amount of 5.5 Million Pesos from the 5%
Calamity Fund for the water supply source development and pipe
installation from Brgy. Milagro, to augment the City Proper water supply
affected by the El Niño; further requesting the Honorable Members of the
8th Sangguniang Panlungsod for the release of the amount of 5.5 Million
Pesos for the herein stated purpose.";

Milagro base water system is the major source of potable water that
