

Larrazabal and Benjamin B. Lladoc; be it


RESOLVED, to pass A RESOLUTION APPROVING THE 1998 SUPPLEMENTAL

ADOPTED, November 5, 1998.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
