


RESOLUTION NO. 98-82

A RESOLUTION EXPRESSING THE HEARTFELT THANKS AND
SINCEREST GRATITUDE OF THE ORMOCANONS TO HIS
EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA FOR
PROCLAIMING NOVEMBER 5, 1998 AS A SPECIAL DAY IN ORMOC
CITY.

WHEREAS, it can be recalled with sadness that on November 5, 1991,
a great tragedy happened in Ormoc City as thousands of lives and million
of pesos worth of properties were lost due to the flash flood brought
about by typhoon "Uring";

WHEREAS, since then, November 5 has been observed as a DAY OF
REMEMBRANCE by Ormocanons wherein appropriate activities and ceremonies
are held to commemorate the day, like the holding of religious
procession, celebrating mass at the common grave, and tree planting;

WHEREAS, His Excellency, President Joseph Ejercito Estrada issued
Proclamation No. 41 DECLARING THURSDAY, NOVEMBER 5, 1998, AS A SPECIAL
DAY IN THE CITY OF ORMOC, thereby giving the Ormocanons the full
opportunity to commemorate the day in remembrance of the victims of the
November 5, 1991 tragedy;

WHEREAS, the Ormocanons are very grateful and thankful to His
Excellency, President Joseph Ejercito Estrada for his kind and
understanding gesture in proclaiming November 5, 1998 as Special Day in
Ormoc City;

WHEREFORE, on MASS MOTION of the Body, with OVERWHELMING SECONDS,
be it;

RESOLVED, to pass a resolution EXPRESSING THE HEARTFELT THANKS AND SINCEREST GRATITUDE OF THE ORMOCANONS TO HIS EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA FOR PROCLAIMING NOVEMBER 5, 1998 AS A SPECIAL DAY IN ORMOC CITY;
