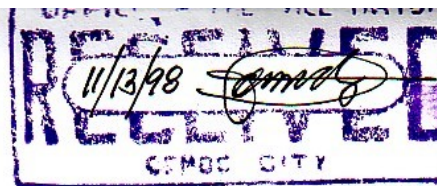
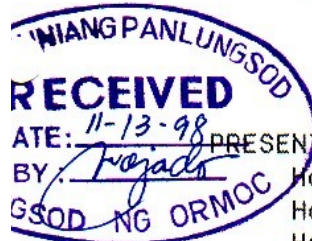

RESOLUTION NO. 98-83

A RESOLUTION RESPECTFULLY REQUESTING HONORABLE MARIA VICTORIA LARRAZABAL LOCSIN, CONGRESSWOMAN, 4TH CONGRESSIONAL DISTRICT OF LEYTE, TO FILE AND SPONSOR A BILL IN CONGRESS DECLARING NOVEMBER 5 OF EVERY YEAR AS A REGULAR NON-WORKING HOLIDAY IN ORMOC CITY TO BE KNOWN AS "REMEMBRANCE DAY IN ORMOC CITY" TO COMMEMORATE THE NOVEMBER 5, 1991 TRAGEDY.

WHEREAS, the November 5, 1991 tragedy in Ormoc City wherein thousands of lives, and millions of pesos worth of properties were lost as a consequence of the killer-flood brought about by typhoon "URING" was not only known in the Philippines but also throughout the world;

WHEREAS, that tragic event has been yearly commemorated in Ormoc City with fitting ceremonies and activities, to remember those who met their untimely death, and as a reminder to all Ormocanons and other Filipinos that MOTHER EARTH, and the environment must be taken care of and must not be abused lest humanity will suffer its fury, as what happened on November 5, 1991;

WHEREAS, the November 5 tragedy, heightened ecological and environmental awareness not only of the Ormocanons but of all Filipinos;

WHEREAS, November 5, has since then been observed as a Special Day in Ormoc City through Presidential Proclamations to give the Ormocanons the full opportunity to commemorate the day;

WHEREAS, it is the sense of this Sanggunian that in order to do away with the yearly requests for a Presidential Proclamation to declare November 5 as a SPECIAL DAY in Ormoc City, that in lieu thereof, a law be enacted for the purpose, and to that end, to respectfully request the Congresswoman of the 4th Congressional District of Leyte, who is the distinguished daughter of Ormoc City, the Honorable Maria Victoria Larrazabal Locsin, to file and sponsor the desired bill;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Benjamin B. Lladoc, Dennis Y. Capuyan and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING HONORABLE MARIA VICTORIA LARRAZABAL LOCSIN, CONGRESSWOMAN, 4TH CONGRESSIONAL DISTRICT OF LEYTE, TO FILE AND SPONSOR A BILL IN CONGRESS DECLARING NOVEMBER 5 OF EVERY YEAR AS A REGULAR NON-WORKING HOLIDAY IN ORMOC CITY TO BE KNOWN AS "REMEMBRANCE DAY IN ORMOC CITY" TO COMMEMORATE THE NOVEMBER 5, 1991 TRAGEDY;

ADOPTED: 12 November 1998.

RESOLVED, FURTHER, to furnish copies of this Resolution each to - Honorable Maria Victoria Larrazabal Locsin, Congresswoman, 4th Congressional District of Leyte; the Honorable Congressmen of the Provinces of Leyte: Honorable Alfredo Romualdez, 1st District Leyte; Honorable Sergio Apostol, 2nd District Leyte; Honorable Edward Veloso, 3rd District Leyte; Honorable Catalina L. Go, 5th District Leyte; and Southern Leyte Congressman, Honorable Anecito Saludo; Biliran Province Congressman, Honorable Gerardo Espina; the Speaker of the House of Representatives, Hon. Manuel Villar; the President of the Philippines Senate, Honorable Marcelo Fernan; the Office of the President of the Republic of the Philippines; the City Mayor of Ormoc, Honorable Eufrocino M. Codilla, Sr.; the DILG City Director, Mr. Rodulfo Torcende, and other Offices concerned;

RESOLVED, FINALLY, to request all the Honorable Representatives of the different Congressional Districts of the Provinces of Leyte, Southern Leyte and Biliran, to support the enactment of the herein desired law;

CARRIED UNANIMOUSLY.
