


RESOLUTION NO. 98-89

A RESOLUTION APPROVING THE REQUEST OF THE ORMOC CITY
PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL
(OCPFSDC) FOR THE USE OF THE ORMOC CITY SUPERDOME AND
APPROVAL TO COLLECT ENTRANCE FEES OF P5.00 FOR GENERAL
ADMISSION, P10.00 FOR THE UPPER BOX AND P15.00 FOR THE
RINGSIDE SEATS FOR THE IMPLEMENTATION OF THE FIRST
ORMOC CITY INTERSECONDARY BASKETBALL LEAGUE.

WHEREAS, this Sanggunian is in receipt of an undated letter from
Mr. Peter Rodriguez, Chairman, OCPFSDC requesting for approval for the
use of the Ormoc City Superdome and approval also to collect entrance
fees as aforesated with the proposal that seventy (70) per cent of the
gate proceeds will be used as payment for the use of the Superdome and
only thirty (30) per cent will be given to the Sports Council as share
of the gate proceeds;

WHEREAS, quoted hereunder is Section 10 of Ordinance No. 64 dated
November 6, 1997:

"Section 10. For activities undertaken by the City in
which entrance fee is collected, the use of the Superdome,
as well as the amount of charges/fees to be collected, shall
be subject to the approval of the Sanggunian. If approved,
proper accounting for the use thereof shall be prepared and
rendered by the Officials concerned within FIFTEEN (15)
working days from the date of such activity, copy of which
shall be furnished the Sanggunian";

WHEREAS, the Eighth Sangguniang Panlungsod ng Ormoc, mindful of the
benefits that will be derived therefrom, has considered said request
valid and reasonable hence, be given due course of action;

NOW, THEREFORE, on motion of Kagawad Chiqui B. Labagala, Chairman, Committee on Youth Development and Sports, jointly seconded by Kagawad Nepomuceno P. Aparis I and Jose S. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE REQUEST OF THE ORMOC CITY PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL (OCPFSDC) FOR THE USE OF THE ORMOC CITY SUPERDOME AND APPROVAL TO COLLECT ENTRANCE FEES OF P5.00 FOR GENERAL ADMISSION, P10.00 FOR THE UPPER BOX AND P15.00 FOR THE RINGSIDE SEATS FOR THE IMPLEMENTATION OF THE FIRST ORMOC CITY INTERSECONDARY BASKETBALL LEAGUE;
