

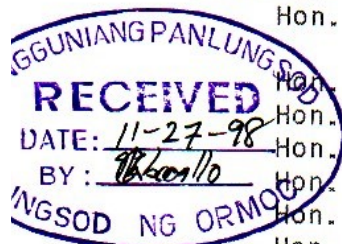

and Claudio P. Larrazabal; be it


RESOLVED, to pass a resolution APPROVING THE 1998 SUPPLEMENTAL
