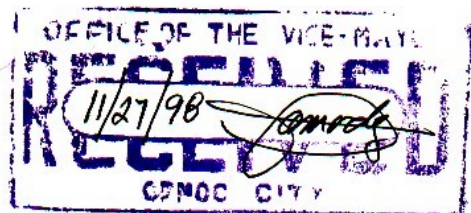

RESOLUTION NO. 98-94

A RESOLUTION SEEKING FROM THE NATIONAL HISTORICAL
INSTITUTE AN ADVICE ON THE PROPRIETY OF RENAMING SAN
VIDAL STREET, AT CANTUBO, DISTRICT 21, THIS CITY, AS
MARGARITO G. TUGONON STREET OR MG TUGONON STREET PER
LETTER REQUEST DATED 2 OCTOBER 1998 OF THE HEIRS OF THE
LATE MARGARITO G. TUGONON REPRESENTED BY ATTY. BENJAMIN
F. TUGONON.

WHEREAS, this august Body is in receipt of a letter dated 2 October
1998 from the heirs of Margarito G. Tugonon, represented by Atty.
Benjamin F. Tugonon addressed the Honorable Members of the 8th
Sangguniang Panlungsod ng Ormoc requesting for the passage and approval
of an Ordinance renaming San Vidal Street at Cantubo, District 21, this
city, as Margarito G. Tugonon Street or MG Tugonon Street, "in honor of
a person who have long died but in life have served unselfishly and
devotedly his constituents in Ormoc City";

WHEREAS, Section 13 Par. (b) of Republic Act 7160, otherwise known
as the Local Government Code of 1991, in part provides:

"(b) The Sanggunians of highly urbanized cities and
component cities whose charters prohibit their voters from
voting for provincial elective officials, hereinafter
referred to in this Code as independent component cities,
may in consultation with the Philippine Historical
Commission, change the name of the following within its
territorial jurisdiction.

X X X

(2) City roads, avenues, boulevards, thoroughfares and bridges"; (Emphasis Supplied).

WHEREAS, the name of a local government unit or a public place, street or structure with historical, cultural or ethnic significance shall not be changed, unless by a unanimous vote of the sanggunian concerned and in consultation with the P.H.C.; (Sec. 13 Par.(d) LGC 1991);

WHEREFORE, foregoing premises considered, on motion of Kagawad Nepomuceno P. Aparis I, Chairman, Committee on Laws & Ordinances, severally seconded by mga Kagawad Claudio P. Larrazabal, Chigui B. Labagala and Sotero M. Pepito; be it

RESOLVED, to pass a resolution SEEKING FROM THE NATIONAL HISTORICAL INSTITUTE AN ADVICE ON THE PROPRIETY OF RENAMING SAN VIDAL STREET, AT CANTUBO, DISTRICT 21, THIS CITY, AS MARGARITO G. TUGONON STREET OR MG TUGONON STREET PER LETTER REQUEST DATED 2 OCTOBER 1998 OF THE HEIRS OF THE LATE MARGARITO G. TUGONON REPRESENTED BY ATTY. BENJAMIN F. TUGONON;
