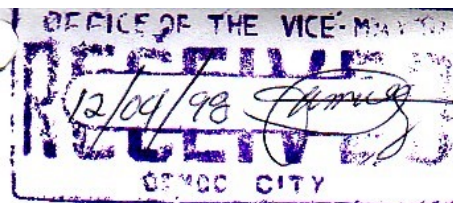
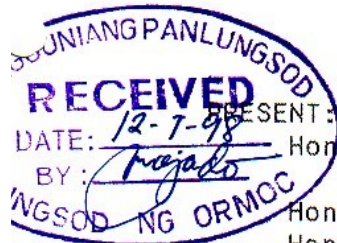

Local Finance Committee;


NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman,

OF BARANGAY MAS-IN AND BARANGAY MATICA-A, BOTH OF THIS CITY;


RESOLVED, FURTHER, to furnish copies of this resolution each to His
