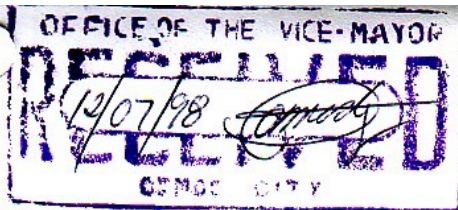
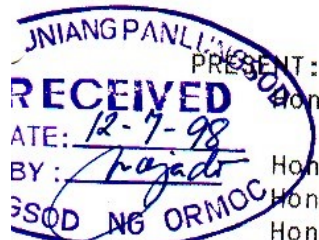

A, 1592-B-2 AND 1592-B-4 AND 1584-A COVERED BY TRANSFER
CERTIFICATE OF TITLE NOS. 31151, 31153, 4758 AND 4767
LOCATED AT BARANGAY CAMP DOWNES, ORMOC CITY WITH AN
AGGREGATE AREA OF 8.2088 HECTARES.

PRESENTED, for consideration by this august Body is the following:

An Application for Preliminary Approval and Locational
Clearance of a Memorial Park of Atty. Benjamin T. Pongos and
Mr. Augusto T. Pongos, applicants, comprising Lot Nos. 1592-
A, 1592-B-2 & 1592-B-4 and 1584-A covered by Transfer
Certificate of Title Nos. 31151, 31153, 4758 & 4767 located
at Barangay Camp Downes, Ormoc City with an aggregate area
of 8.2088 hectares;
