

JACOB OF THE SECOND DISTRICT OF CAMARINES SUR, WHICH SEEKS TO AMEND THE EXISTING RULES AND PROCEDURES IN THE USE OF CALAMITY FUNDS.

WHEREAS, this Sanggunian is in receipt of Resolution No. from the Sangguniang Panlungsod ng Naga entitled, "RESOLUTION URGING THE LEAGUE OF CITIES OF THE PHILIPPINES TO SUPPORT HOUSE BILL NO. 4578 FILED BY REPRESENTATIVE JAIME S.
