

A RESOLUTION SUPPORTING RESOLUTION NO. 076 SERIES OF 1998
OF THE SANGGUNIANG PANLUNGSOD NG DAVAO, ENTITLED:
"PROPOSED RESOLUTION REQUESTING THE PHILIPPINE NATIONAL
POLICE THROUGH THE NATIONAL POLICE COMMISSION TO
REQUIRE ALL POLICE PERSONNEL, REGARDLESS OF RANK, TO
UNDERTAKE PSYCHIATRIC AND DRUG TEST AT LEAST TWICE A
YEAR AND TO INCLUDE SUCH TESTS AS INTEGRAL PART OF ITS
NATIONAL POLICY."

WHEREAS, this Sanggunian is in receipt of a copy of Resolution No.
076 from the Sangguniang Panlungsod ng Davao entitled, "PROPOSED
RESOLUTION REQUESTING THE PHILIPPINE NATIONAL POLICE THROUGH THE
NATIONAL POLICE COMMISSION TO REQUIRE ALL POLICE PERSONNEL, REGARDLESS
OF RANK, TO UNDERTAKE PSYCHIATRIC AND DRUG TEST AT LEAST TWICE A YEAR
AND TO INCLUDE SUCH TESTS AS INTEGRAL PART OF ITS NATIONAL POLICY";

WHEREAS, said resolution mentions that there is a need for both the
"mental and physical astuteness of all police personnel be a prime
concern of the PNP and shall be regularly monitored by the authorities
as requirement for continued service;"

Honorable Chairman, Committee on Police Matters expresses its concern by
way of this resolution of support for the reasons stated therein;

WHEREFORE, foregoing premises considered, on motion of Kagawad Jose
C. Alfaro, Jr., Chairman, Committee on Police Matters, jointly seconded
by Kagawad Chiqui B. Labagala and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution SUPPORTING RESOLUTION NO. 076 SERIES OF 1998 OF THE SANGGUNANG PANLUNGSOD NG DAVAO, ENTITLED: "PROPOSED RESOLUTION REQUESTING THE PHILIPPINE NATIONAL POLICE THROUGH THE NATIONAL POLICE COMMISSION TO REQUIRE ALL POLICE PERSONNEL, REGARDLESS OF RANK, TO UNDERTAKE PSYCHIATRIC AND DRUG TEST AT LEAST TWICE A YEAR AND TO INCLUDE SUCH TESTS AS INTEGRAL PART OF ITS NATIONAL POLICY;"
