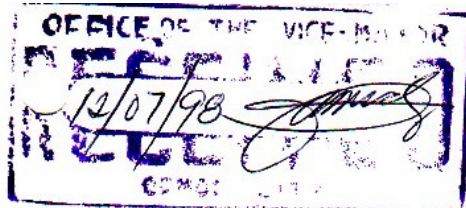
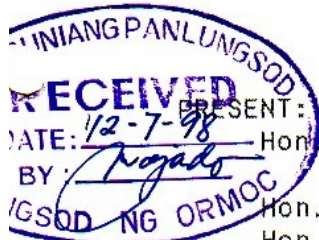

seconded by Kagawad Jose C. Alfaro, Jr., and Eduardo P. Tan; be it


RESOLVED, to pass a resolution TRANSFERRING THE REGULAR SESSION OF


