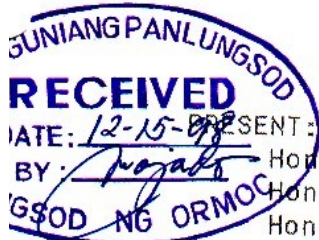

Pepito and Eduardo P. Tan; be it




