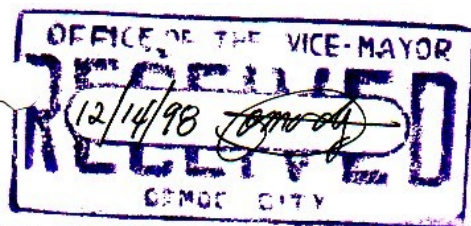
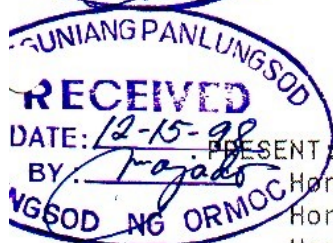

Local Finance Committee;


NOW, THEREFORE, on motion of Kagawad Benjamin B. Lladoc, Vice-

BUDGET NO. 05 OF BARANGAY DONGHOL, THIS CITY;


RESOLVED, FURTHER, to furnish copies of this resolution each to His
