

RESOLUTION NO. 98-114

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 98-001 OF THE BARANGAY COUNCIL OF QUEZON JR., THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON STORES, OR BILLBOARDS, SIGNBOARDS, PRIVELEGE RETAILERS (SIC) PANELS, AND OTHER OUTDOOR ADVERTISEMENTS, AND CHARGING IN THE ISSUANCE OF BARANGAY PERMITS, CLEARANCES."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 98-001 of Barangay Council of Quezon Jr., this city, entitled: "AN ORDINANCE TAXES ON STORES, OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVELEGE (SIC) PANELS, AND OTHER OUTDOOR ADVERTISEMENTS, AND CHARGING FEES IN THE ISSUANCE OF BARANGAY PERMITS, AND CLEARANCES;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city X X X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, it is the observation of this august Body, through the representation of the Honorable Chairman, Committee on Laws and Ordinances that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. Quezon Jr., to legislate;

WHEREFORE, foregoing premises considered, on motion of Kagawad Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances. jointly seconded by Kagawad Mariano Y. Corro and Benjamin B. Lladoc; be it
