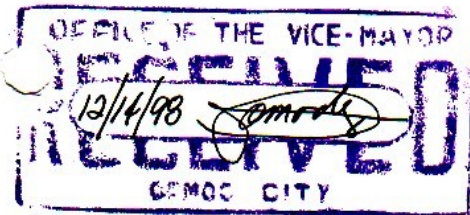
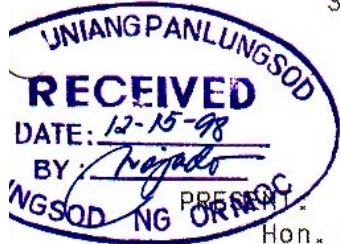

RESOLUTION NO. 98-115

A RESOLUTION AMENDING PARAGRAPH TWO OF SP RESOLUTION NO. 98-75 OF THE EIGHTH SANGGUNIANG PANLUNGSOD NG ORMOC DATED 29 OCTOBER 1998, ENTITLED, "A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF 5.5 MILLION PESOS AGAINST THE 5% CALAMITY FUND FOR THE WATER SUPPLY DEVELOPMENT AND PIPE INSTALLATION FROM BARANGAY MILAGRO TO AUGMENT THE WATER SUPPLY OF ORMOC CITY AFFECTED BY THE EL NIÑO PHENOMENON."

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 3 December 1998 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting to extend appropriate action for the immediate implementation of the water supply development project at Brgy. Milagro, this city;

WHEREAS, paragraph two of aforementioned SP Resolution No. 98-75, reads as follows:

"WHEREAS, in order for the City Government of Ormoc to save, this august Body on its Pre-Session Caucus, has agreed that said project be undertaken by the Administration considering that the 5% Calamity fund is almost exhausted and the balance of which will still be used for emergency purposes;"

WHEREAS, per opinion of City Legal Officer of Ormoc, Atty. Cleto L. Evangelista, Jr. and observations of Waterworks Superintendent, Engr. Gervacio L. Germano, Jr., it is not feasible, advisable and practical that subject project be undertaken by administration for the following reasons, to wit:

- 1) The materials (pipes and fittings) are not readily available in the local market.
- 2) If said materials are to be purchased through bidding, the process would take time and that the administration cannot be sure if the estimated prices are at par with local supplier's prices.
- 3) Pipe manufacturers demand at least 50% down payment prior to delivery - contrary to existing government purchasing policies.
- 4) Government owned heavy equipments are not available since it is used by CEO projects.

WHEREAS, in view of the foregoing opinion of City Legal Officer Cleto L. Evangelista, Jr. and observations of Waterworks Superintendent Gervacio L. Germano, Jr., subject project will be undertaken by a competent contractor subject to existing laws, rules and regulations, instead of by administration as provided for in paragraph two of SP Resolution No. 98-75, hence said resolution specifically paragraph two thereof is amended accordingly.

WHEREFORE, foregoing premises considered, on motion of Kagawad Sotero M. Pepito, Vice-Chairman, Committee on Infrastructures, jointly seconded by Kagawad Mariano Y. Corro and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AMENDING PARAGRAPH TWO OF SP RESOLUTION NO. 98-75 OF THE EIGHTH SANGGUNIANG PANLUNGSOD NG ORMOC DATED 29 OCTOBER 1998, ENTITLED, "A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF 5.5 MILLION PESOS AGAINST THE 5% CALAMITY FUND FOR THE WATER SUPPLY DEVELOPMENT AND PIPE INSTALLATION FROM BARANGAY MILAGRO TO AUGMENT THE WATER SUPPLY OF ORMOC CITY AFFECTED BY THE EL NIÑO PHENOMENON;"

ADOPTED, December 11, 1998.
