

RESOLUTION NO. 98-116

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01 S. 1998
OF BARANGAY QUEZON JR., THIS CITY, ENTITLED, "AN
ORDINANCE FIXING THE FILING FEE FOR ANY COMPLAINT FILED
WITH THE LUPONG TAGAPAMAYAPA, BY ANY PERSON IN THE
BARANGAY."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 98-01 of
Barangay Quezon Jr., this city, entitled, "AN ORDINANCE FIXING THE
FILING FEE FOR ANY COMPLAINT FILED WITH THE LUPONG TAGAPAMAYAPA, BY ANY
PERSON IN THE BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangays in Ormoc City), is by law, granted the Power of
Review as to whether the said ordinance is consistent with law and city
