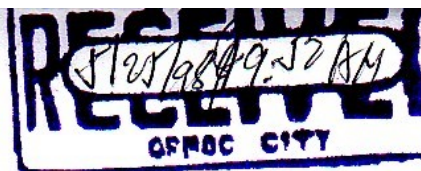
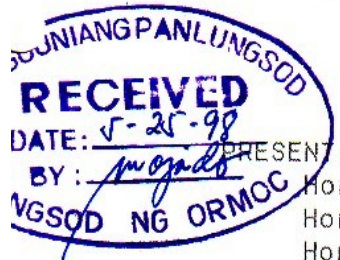

RESOLUTION NO. 98-117

A RESOLUTION INTERPOSING NO OBJECTION TO THE LAND USE CONVERSION OF A LAND MORE PARTICULARLY DESCRIBED AS LOT NO. 7765-E COVERED BY TCT NO. 30610; LOT NO. 7765-G COVERED BY TCT NO. 30612; AND LOT NO. 7768 COVERED BY TCT NO. 30615 WITH A TOTAL AREA OF 3.5211 HECTARES TO BE USED AS A SOCIALIZED HOUSING SUBDIVISION PROJECT, CONSIDERING THAT THE AREA IS URBANIZED AND IS IN CONSONANCE WITH THE ZONING POLICIES OF THE CITY PLANNING OFFICE AS CERTIFIED BY THE OIC-CITY PLANNING AND DEVELOPMENT COORDINATOR OF ORMOC CITY, PROVIDED, THAT THIS RESOLUTION SHOULD NOT BE CONSTRUED AS A LOCATIONAL CLEARANCE NOR A PRELIMINARY APPROVAL OF THE SAME.

WHEREAS, this Sanggunian is in receipt of a letter dated 16 April 1998 from Gregoria B. Soria, President, United Village Homeowners' Association requesting for approval of land use conversion for socialized housing project located at Barangay Juaton, this city;

WHEREAS, based on the documents presented and other papers submitted, this august Body has found out that said project is in consonance with the zoning policies of the City Planning and Development Office and same office recommends for approval, however, requirements of other government agencies shall be complied with in accordance with RA 6657 (CARP LAW);

WHEREFORE, foregoing premises considered, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Zoning and Beautification, jointly seconded by Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INTERPOSING NO OBJECTION TO THE LAND USE CONVERSION OF A LAND MORE PARTICULARLY DESCRIBED AS LOT NO. 7765-E COVERED BY TCT NO. 30610; LOT NO. 7765-G COVERED BY TCT NO. 30612; AND LOT NO. 7768 COVERED BY TCT NO. 30615 WITH A TOTAL AREA OF 3.5211 HECTARES TO BE USED AS A SOCIALIZED HOUSING SUBDIVISION PROJECT, CONSIDERING THAT THE AREA IS URBANIZED AND IS IN CONSONANCE WITH THE ZONING POLICIES OF THE CITY PLANNING OFFICE AS CERTIFIED BY THE OIC-CITY PLANNING AND DEVELOPMENT COORDINATOR OF ORMOC CITY, PROVIDED, THAT THIS RESOLUTION SHOULD NOT BE CONSTRUED AS A LOCATIONAL CLEARANCE NOR A PRELIMINARY APPROVAL OF THE SAME;
