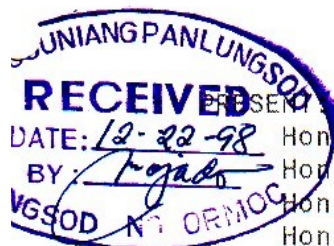

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST CURRENT APPROPRIATION FOR OUTLAY FOR LEAVE

TERMINAL LEAVE OF FORMER KAGAWAD JOSE B. CONEJOS
AMOUNTING TO FIFTY ONE THOUSAND SEVEN HUNDRED SIX
PESOS & 85/100 (P51,706.85).

PRESENTED, for consideration by this Sanggunian is a letter dated
03 December 1998 from Jose B. Conejos, former Kagawad, Sangguniang
Panlungsod ng Ormoc addressed the Hon. Eufrocino M. Codilla, Sr., City
Mayor, requesting for an appropriation in the amount of P51,706.85 as
payment for his terminal leave;

WHEREAS, said request for terminal leave payment has been

Kagawad Nepomuceno P. Aparis and Benjamin B. Lladoc; be it


RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO
