

## RESOLUTION NO. 98-122

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST CURRENT APPROPRIATION FOR OUTLAY FOR LEAVE CREDITS OF THE SANGGUNIANG PANLUNGSOD NG TERMINAL LEAVE OF FORMER KAGAWAD JOSE B. AMOUNTING TO FIFTY ONE THOUSAND SEVEN HUNDRED SIX PESOS & 85/100 (P51,706.85).

PRESENTED, for consideration by this Sanggunian is a letter dated 03 December 1998 from Jose B. Conejos, former Kagawad, Sangguniang Panlungsod ng Ormoc addressed the Hon. Eufrocino M. Codilla, Sr., City Mayor, requesting for an appropriation in the amount of \$51,706.85 as payment for his terminal leave;

WHEREAS, said request for terminal leave payment has recommended to be charged against Current Appropriation for Outlay for Leave Credits, Office of the Sangguniang Panlungsod as requested by the Secretary to the Sangguniang Panlungsod (letter-request for augmentation addressed the City Budget Officer) through a letter dated 03 December 1998 and same has been approved by the Honorable City Mayor;
