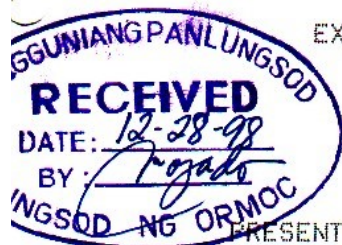

Sotero M. Pepito and Dennis Y. Capuyan; be it


RESOLVED, to pass a resolution APPROVING THE 1998 SUPPLEMENTAL
