

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST CURRENT APPROPRIATION - OTHER SERVICES - OF THE
SANGGUNIANG PANLUNGSOD, THE AMOUNT OF THREE THOUSAND
FOUR HUNDRED TWELVE PESOS (P3,412.00) REPRESENTING
PAYMENT OF TELEPHONE INSTALLATION AT THE RESIDENCE OF
FORMER SP MEMBER MANUEL T. FIEL.

PRESENTED, for consideration by this august Body is a letter dated
04 December 1998 addressed the Sangguniang Panlungsod thru the Hon. City
Vice Mayor from Manuel T. Fiel, former SP Member, this city, requesting
payment in the amount of P3,412.00 representing cost of installation of
telephone at his residence during his incumbency as City Kagawad;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 16
December 1998 has stated that said amount be charged to current
appropriation - Other Services - Office of the Sangguniang Panlungsod;

WHEREAS, the OIC-City Treasurer through 5th Indorsement dated 21
December 1998 has stated that fund is available subject however to
accounting and auditing rules and procedures;

Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by
Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO

SANGGUNIANG PANLUNGSOD, THE AMOUNT OF THREE THOUSAND FOUR HUNDRED TWELVE
PESOS (P3,412.00), REPRESENTING PAYMENT OF TELEPHONE INSTALLATION AT THE
RESIDENCE OF FORMER SP MEMBER MANUEL T. FIEL;
