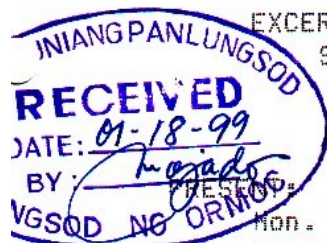

requesting for a resolution interposing no objection to the proposed
socialized residential subdivision at Barangay Luna, Ormoc City;

WHEREAS, said SP Resolution is a requirement for the proponent's
application for Environmental Clearance Certificate (ECC) with the
Department of Environment and Natural Resources (DENR), Regional Office,
Tacloban City in connection with the said proposed socialized
residential subdivision located at Brgy. Luna, this city;
