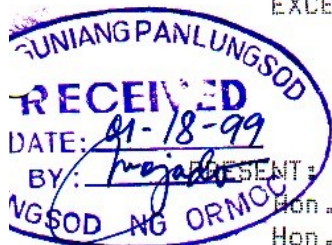

RESOLUTION NO. 99-05

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 98-01 OF
BARANGAY MARGEN, THIS CITY, ENTITLED: "AN ORDINANCE
REGULATING THE UTILIZATION OF OUR WATER SYSTEM TO
PROMOTE A FAIR AND EQUITABLE DISTRIBUTION OF OUR WATER
RESOURCE."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 98-01 of
Barangay Margen, this city, entitled, "AN ORDINANCE REGULATING THE
UTILIZATION OF OUR WATER SYSTEM TO PROMOTE A FAIR AND EQUITABLE
DISTRIBUTION OF OUR WATER RESOURCE;"
